In our last newsletter we wrote of CSR and the Federal Court decision to block the proposed demerger of CSR's sugar business. CSR appealed the decision and a FULL bench of the Federal Court has upheld an appeal by CSR over its planned demerger but left open the prospect of further legal challenges to the demerger on asbestos compensation concerns.

The decision means CSR can hold a shareholder vote on the demerger but could face another fight when its scheme of arrangement returns, as required under the Corporations Act, to the Federal Court for approval after the shareholder meeting.

The judgment also said CSR's opponents, who argue that the demerger poses unacceptable risk that there will be insufficient funds to compensate sufferers of asbestos diseases, could bring their own legal action to stop it.

AVA along with other groups from Qld. Vic. and NSW were given an information meeting by CSR in mid May and at this stage we are not totally happy.

CSR are producing an information booklet for their share holders due sometime near the end of June so it is hoped that CSR will again offer the groups more information .

We will keep members informed as things proceed.

#### What are the Early Warning Symptoms?

#### Contact your doctor immediately if you experience any of the following symptoms:

- Persistent pain in the lower back, shoulder, or chest wall
- Shortness of breath
- Appearance of lump or mass on chest wall
- New onset of persistent dry cough
- Coughing up blood
- Persisting loss of energy, fatigue or anemia
- Losing weight for no apparent reason
- Onset of hoarseness or a change in voice
- Persistent swelling of face and/or arms
- Muscle weakness
- Abdominal pain and or distention
- Nausea and or vomiting

### **NANNA Shirley's KITCHEN**

# **INGREDIENTS**

3/4 cup dried apricots 1/2 cup coconut 1/4 cup pitted prunes 1/2 cup skim milk powder 1 tablespoon lemon juice 1/2 cup pitted dates

### **METHOD**

1 Chop all fruit finely and firmly mix together

1/2 cup sultanas

2 Pour over 1/4 cup boiling water and set aside for 10 mins or until liquid has been absorbed

3 Add milk powder, coconut and lemon juice. Mix well

4 Divide into walnut sizes

5 Roll in coconut

6 Place on tray and refrigerate until firm

7 You can freeze them until you're ready to use
