Back in the April/May newsletter we informed you of the asbestos issue in the small country town of Terowie. Many residents were concerned about the lack of response to have the area cleaned up.

Geoff Maul our AVA support representative in Port Augusta, became involved with the residents and reports now that the residents are satisfied with the final outcome with the area being cleaned up and signage displayed.

Now Geoff has come across a heavily contaminated site in Port Augusta, and it is taking some time to get remediation started. Council has been notified as have EPA, and the companies responsible for the property, but at the time of writing this there has been no clean up, fencing or warning signage.

Geoff has taken a very graphic video showing the extent of the asbestos contamination and gave a copy to the local MP, who then forwarded a copy to a couple of State Govt. Ministers. We also have a copy of this video, and we are following this thru with a number of Govt. Depts.

AVA would encourage everyone who comes across areas that are contaminated with asbestos regardless where it may be, including illegally dumped asbestos to notify their council, and notify AVA so we can monitor any action or lack of action and deal with it.

We invite anyone, who would like attend, to come along to our monthly meetings held on the First Friday of each month.



FROM AVA'S LEGAL ADVISOR ANNIE HOFFMAN

Van Soest v BHP Billiton Limited

On 17 June 2013 Judge Parsons of the District Court of South Australia handed down judgment finding BHP liable in negligence to Mr van Soest in relation to his condition of mesothelioma.

Mr van Soest worked as a painter and docker at the BHP Whyalla Shipyard for a period of 12 weeks in 1962.



Mr van Soest was also required to help the laggers on occasions with their work and to clean up after the laggers, sweeping up asbestos dust.

Years later, in 2011, Mr van Soest was diagnosed with mesothelioma. He brought proceedings in the District Court of South Australia against BHP.

BHP aggressively defended the claim, putting all matters in issue. In her Judgment Judge Parsons found that in 1962 BHP knew that the process of installing asbestos insulation on its ships carried with it a risk of contracting asbestosis.

She also found that BHP should have taken measures to limit exposure to asbestos dust including providing their workforce with respirators and vacuum cleaners to clean up the dust.

Judge Parsons also found that Mr van Soest's exposure to asbestos had made a material contribution to the development of his condition of mesothelioma.

In a separate judgment delivered on 28 June 2013 Judge Parsons awarded Mr van Soest a total of \$358,151.30.

This sum included an award of \$20,000 for exemplary damages.

Exemplary damages are awarded under the Dust Diseases Act 2005 (SA) where it can be shown that the defendant knew at the time of the plaintiff's exposure to asbestos that the plaintiff was at risk of exposure to asbestos, and also knew that exposure to asbestos dust could result in a dust disease.

The award is the second award of exemplary damages to be made against BHP under the Dust Diseases Act.

BHP have appealed the Judgment to the Full Court of the Supreme Court of South Australia.

COMMENT!!

In an asbestos claim in recent times Hamilton v BHP Billiton, the District Court of SA in June last year found in favour of Hamilton after finding BHP negligent in duty of care.

BHP Billiton appealed against the decision of the District Court, and in the past few weeks the Full Court of the Supreme Court of SA dismissed the appeal by BHP Billiton. In their judgement Chief Justice Kourakis, Justice Blue, and Justice Stanley found BHP Billiton was negligent in failing to identify steps to reduce its workers' inhalation of asbestos dust.

It seems to us that if BHP the (Big Australian) don't like decisions going against them in one court they are quick to lodge an appeal to another court


